TRADE CIRCULAR No. 14/2009

Date: December 31st, 2009

Reg.: Submission of application for and delivery of the statutory forms under the Central Sales Tax Act, 1956.

In Trade Circular No. 4/2009 dated 5.07.2009, the date for filing online applications for CST related Declaration Forms and Certificates for the periods from 01.04.2004 to 31.03.2008 was extended upto 30.09.2009 in place of 30.06.2009. Considering representation by a section of trade, the above-noted date for filing online applications for CST related Declaration Forms and Certificates for the periods from 01.04.2004 to 31.03.2008 was further extended upto **31.12. 2009 by issue of Trade Circular No. 7/2009 dated 17.9.2009.**

Similarly in Trade Circular No. 5/2009 dated 20.07.2009, the date for filing applications **in paper form** for CST related Declaration Forms and Certificates for the periods up to 31.03.2008 was extended up to 30.09.2009 in place of 30.06.2009. It was again extend upto **31.12. 2009 by issue of Trade Circular No. 7/2009 dated 17.9.2009.**

Now several representations are coming from trade & commerce which show that a good number of dealers have not yet completed their task of filing petitions for issue of declaration forms in the prescribed way. Considering their representations it is now decided that the date for filing online application as well as application in paper form shall be extended further **upto 31.3.2010. No further extension will hereafter be given.**

Dealers may strictly follow the deadline for their own benefits.

All concerned are requested to bring the contents of this circular to the notice of the dealers.
